General Instructions for Candidates

- 1. The posts is Non Government and will be governed by New Pension Scheme introduced by Govt. of India. w.e.f. 01.01.2004 and service conditions are mutatis mutandis as applicable to Indian Council of Agricultural Research employees and as amended from time to time.
- 2. The post is temporary but likely to continue and transferable to anywhere in India.
- 3. Maximum age limit for the post is 18 to 30 years. Upper age limit relaxation upto 5 years for SC/ST candidates, 3 year for OBC candidates and 10 years for Person with Disabilities

- (PwD) candidates is admissible as per rules. Age relaxation will also be allowed to ICAR employees / Research Associates/Senior Research Fellows as per existing instructions.
- 4. Crucial date for determining the age limit of candidates for the post will be as **on 01-01-2016.** Persons already in employment should route their applications through proper channel only. In case a candidate anticipants delay in forwarding of his / her application through proper channel, he /she must send an advance copy of the application along with fee which must reach this office on or before the closing date.
- 5. The prescribed qualifications is the minimum required for the post and enhanced qualifications does not entitle candidates to be called for written test. Where the number of applications received in response to advertisement is large and it will not be convenient OR possible for the Institute to call for Test to all candidates, the Director, ICAR NRCG reserves the right to fix the criteria for calling the candidates for written test on the basis of qualification.

Candidates before applying for the post must satisfy that they are eligible to apply and fulfill the criteria, essential qualification, age etc. prescribed for the post.
