- 3. **Age limit for YP-I / YP-II:** Minimum 21 Years and Maximum 45 Years as on last date of submission of application with relaxation as per rules.
 - **Age limit for SRF:** Maximum age is 35 years for men and 40 years for women as on last date of submission of application with relaxation as per rules.
- 4. The above positions are purely temporary basis and co terminus with the project subject to satisfactory performance. The selected candidates shall have no right/ claim for regular appointment or absorption at ICAR-NRCG at any point of time.
